1. Superintendent Report

Included with the Agenda was a copy of the Superintendent's report (see Exhibit C). Mr. Tony Manfre presented his report which included updates on the Treatment Plant, collection systems, capital improvement project updates, and collection of sewer fees.

Mr. Toby Lewis asked Mr. Manfre if the hairline crack found on the Clark Street Force Main is an indication of potential problems elsewhere in town. Mr. Manfre explained they are actively inspecting sewer infrastructure and addressing issues by repairing or replacing pipes, manholes, and relining pipes. Pipes that were installed in the 1970's are deteriorating, as sewer infrastructure lifespan averages 50-70 years.

1. Budget Discussion

Mr. Tony Manfre referenced the proposed budget that was shown at the public hearing (see Exhibit A). Mr. Toby Lewis asked how the Capital Improvement Project Budget is funded, and Mr. Manfre responded that it is funded by sewer user rates.

Mr. James Murray asked how the bill for the surcharge rate works. Mr. Manfre stated the town charges the industry user that is discharging above the limit and the additional cost is based on the cost of removal of BOD and TSS.

Mr. Cordeiro asked, since the pipes are 50 years and older, if it has been considered to increase the Capital Improvement Budget to address the anticipated issues and costs. Mr. Manfre explained there is a WPCA reserve set aside for catastrophes, and that there is a 10-year capital improvement plan for these types of projects.
